Pertaining to registration of students of Self-financed D.El.Ed Institutes for the Session: 2021 – 2023

The modified interim direction dated 06/06/2023 passed in WPA [P] 1/2023 [Sukanta Guria 1. Vs. State of West Bengal & Ors.] with WPA [P] 270/2023 [Sukanta Guria Vs. State of West Bengal & Ors.] by the Hon'ble Chief Justice & the Hon'ble Justice Hiranmay Bhattacharyya inter alia reads thus:

> "The respective institution in which the students are said to have pursued the course of study shall pay the late fee of Rs.3,000/- per student subject to the outcome of this writ petition."

- 2. - 3. Such admission forms must be submitted between 09/06/2023 to 13/06/2023 with late fee of Rs. 3, 000/- (Rupees Three thousand) only per student. The late fee is to be paid by the Self-financed D.El.Ed Institute(s), as directed.
- 4. Those Institutes who have submitted admission forms of their students between 31/05/2023 to 02/06/2023 with late fee of Rs. 3,000/- (Rupees Three thousand) only per student [prior to issuance of memo no. 123/WBBPE/D.El.Ed./2023 dated 02/06/2023] are not required to submit afresh.
- 5. By dint of the modified interim direction dated 06/06/2023, passed by the Hon'ble Court, the suspension of submission of admission forms as contained in memo no. 123/WBBPE/D.El.Ed./2023 dated 02/06/2023, is hereby withdrawn.
- The other terms & conditions of notification no.- 120/WBBPE/D.El.Ed/2023 dated -30/05/2023 will remain unaltered.
